In the event that he/she disagrees with any amendment to the current rules, the undersigned understands that they have the right to terminate this permit within 10 days of the effective date of the amendment, which termination shall be in writing and mailed Riverside Speedway at its Groveton, NH address. In addition, the undersigned agrees to be bound by any and all decisions made by Riverside, which decisions shall be final and without recourse or appeal. In the event that this permit is voided, cancelled, terminated or that permit holder is suspended or banned from competition, it shall be without restitution of any part of the fee paid in connection with this application, and further, the undersigned waives any and all rights or claims to any point fund or bonus money due them resulting from their racing efforts with Riverside Speedway prior to termination. The undersigned further waives any and all rights for self, their agents and assigns, to institute any action, suits or proceedings, whether at law, in equity or before any administrative agency or board in any jurisdiction, whether under the laws of the United States of America or Canada or any political subdivision of either Country against Riverside Speedway any of its employees, agents, or servants or any persons for whose activities Riverside Speedway may be responsible, arising out of the promoting, sanctioning,**
